MEMBERSHIP PRIVILEGES: I hereby acknowledge that the facilities are owned and operated by Brookhill, LLC and its affiliates, and membership in The Clubs at Ole Brook permits the member(s) to use The Club facilities, but it is not an investment nor does it confer any equity ownership interest or any other property interest in the facilities. Membership in The Clubs does not give a member a vested or prescriptive right to receive any assets if Brookhill, LLC is dissolved. I further acknowledge that The Clubs at Ole Brook reserves the right to terminate or modify the membership plans, or discontinue operation of any and all of the facilities, to sell or otherwise dispose of the facilities, and/or to convert to an equity member-owned facility. I understand that a member has no right to vote or to otherwise become involved in the management of Brookhill or The Ole Brook. The payment of the membership deposit, dues, fees, capital improvement assessments, personal and other charges as Brookhill may establish from time to time is required to acquire and maintain membership privileges. With the exception of these membership charges, members are not subject to any liability or assessment for the cost and expenses of ownership or management of Brookhill, LLC dba The Clubs at Ole Brook.

INITIAL BESIDE EACH:

_____ Membership in The Clubs at Ole Brook is for a minimum of one year. **IF membership is terminated by the member within one year of the joining date, member will be liable for remaining monthly dues owed in the contractual membership year.** The exception will be if membership is terminated due to death or moving residence of more than fifty (50) miles from either location.

_____ Upon acceptance as a member of The Clubs at Ole Brook, an account will be set up for the member to allow dues and fees to be charged. The member will have access to a member portal of said charges at the end of each month. Payment of dues and/or charges is due upon receipt of the monthly statement. Members may be charged a late fee if payment has not been received by the business office by the 25th of the succeeding month.

_____ **CANCELLATION of MEMBERSHIP:** Cancellation of membership must be emailed to The Clubs at Ole Brook business office at play@theclubsatolebrook.com or submitted in writing to the business office located at 208 S. Whitworth Avenue, Brookhaven, MS, 39601. Cancellation must be postmarked or received by email thirty (30) days in advance. All amounts owed to The Clubs at Ole Brook will be due and payable at that time. Any amounts not paid to The Club will be subject to collection procedures. All costs incurred in the collection of past due amounts will be borne by the member.

WAIVER of LIABILITY:

In consideration of being allowed to participate at Brookhill on Natchez or The Ole Brook, the undersigned:

- a. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of injury which might result not only from their own actions, but from the inactions or negligence of others, the rules of play, or the condition of the premises and/or any equipment used.
